**REVISED ORDER**

**Proceedings No. E-6797/2024/KSMC/Homoeo dated 21/10/2024**

As per ref (2) the enrolment procedure came into effect on 11/07/2024 and  
as per ref (3) the joint sitting of members of National Commission for Homoeopathy  
(NCH) and Council of Homoeopathic Medicine of Kerala State Medical Councils  
decided to raise the enrolment and re-enrolment periods from existing 3 year period to 5  
years respectively. It was also decided to double the fee structure for registered  
practitioners (excluding PG Students).The revised fee structure for enrolment is detailed  
below.
