Sir/Madam,

With reference to the subject mentioned above, it is to inform you that the National Health Authority (NHA), Government of India has decided to promote digitization in the healthcare system through the Ayushman Bharat Digital Mission (A.B.D.M.) with the aim of developing a "Digital Health Ecosystem" in the country, its implementation is expected to significantly improve the efficiency, effectiveness, and transparency of health service delivery overall.

For this purpose you are requested to sensitize the practitioners of ASUS fraternity of your state to register themselves in the portal to avail the benefits and for the upliftment of health services. The procedure for registration is as follows:

For registering in Health Professional Registry (HPR).

Step 1: For registering as health care provider registry (HPR) login https://hpr.abdm.gov.in/ or On Browser ype www.hpr.abdm.gov.in.

Step 2: Select Registration Council, Enter Reg. No. (Only Numbers in it), Select Cat: Doctor, Sub Cat: Ayurved, Tick the Captcha, Click Submit

Step 3: Continue with Generate via Aadhar, You can also Generate Via Driving Licence however then you will have to manually submit your Form

Step 4: Enter Your Aadhar No., Scroll & Click on 'I Agree', Solve the Captcha, Click on Submit

Step 5: Your Aadhar Details Will be Visible, Select Cat: Doctor Sub Cat: Ayurved, Type Username of your Choice, Type Your Personal Email, Type Password of your Choice, Enter State & District of Practice, Click on Submit Step 6: Hereafter You can Click Here to Complete, Your HPR Number Is Generated. '

For registering in Health Facility Registry (HFR),

Step 1: Locating the facility in Health Facility Registry - Open https://facility.abdm.gov.in/ enter the parameters such as State, District, and Facility Name etc. Click on Search and find your facility if previously registered. If not registered, proceed for fresh registration.

Step 2: Facility Manager Registration -Sign up for a Healthcare Professional ID with role as a Facility Manager by clicking the concerned window.

Step 3: Completing the Registration formalities-The Facility Manager will login to the HFR using the Healthcare Professional ID, and submit basic details such as facility name, address, geo-location, contact details, ownership, facility type, timings, photographs etc.

Step 4: Verifying the submitted details- This involves verification of the submitted application by the District Verifier.

The Ayushman Bharat Digital Mission (ABDM) has been launched by the Government of India for promoting digitization of healthcare and is applicable to every citizen of India. An ABHA is a unique 14-digit number assigned to individuals to store all your digital health records at one place and share these records with hospitals/doctors you visit, with your consent, with suitable applications. ABHA number will establish a strong and trustable identity for you that will be accepted by healthcare providers and payers across the country.

### For registering in Ayushman Bharat Health Account (ABHA),

Step 1: On your mobile / PC / Laptop, On Browser Type www.healthid.ndhm.gov.in, Click 'Create ABHA Number'.

- Step 2: Select Using Aadhar, Click 'Next'.
- Step 3: Your Aadhar Number, Click 'I Agree', Write the Answer, Click 'Next'.
- Step 4: Type, OTP received on Mobile, Click 'Next'.
- Step 5: Your Aadhar Profile Is seen, Click 'Next'.
- Step 6: Enter Your Mobile Number Again, Click 'Next'.
- Step 7: Click 'Skip for Now'
- Step 8: On the Next Screen Click Your ABHA No. is generated and is shown on screen and sent as SMS.

Further, National Health Authority has recently launched the "Digital Health Incentive Scheme (DIMS)" for digitization of patient health records. This scheme provides financial incentives upto Rs. 4 Crores to hospitals, laboratories, diagnostic centers, and health-tech companies for creation of ABHA-linked health records. DHIS has been rolled out from 1st January 2023. Details of the DHIS are available at https://abdm.gov.in/DHIS

For availing these facilities the HPR, HFR and ABHA registration are mandatory. Therefore, it is requested that all the ISM practitioners and the Health care Facilities should be immediately registered in order to implement the ABDM scheme in your state fruitfully.
