The Post Graduate Students who have been qualified in All India Ayush Post Graduate Entrance Test and got allotment in Kerala for pursuing Post Graduation Degree Courses and for those registered practitioners of homoeopathy of other States and Union Territories who decide to practice /seek job opportunities in our State (excluding employment via Kerala Public Service Commission) can enroll themselves in the Adjunct (Enrollment) Register maintained by Kerala State Medical Councils – Homoeopathy without cancelling their respective permanent registration and getting NOC from concerned State Council. The temporary registration procedure intiated by Kerala State Homoeopathy Council for PG students put into effect by the Homoeo Council decision dated 11/07//2022 based on provisions of the Kerala State Medical Practitioners Act,2021, stands replaced by the new enrollment procedure laid out in the regulation 8 of the National Commission for Homoeopathy (Manner of preparation & maintenance of National Register for practitioners of Homoeopathy) Regulations, 2022 and by the decision of Homoeopathy Council dated 03/04/2024. The fee structure of enrollment procedure is shown below.

The applicants at present are requested to effect payment via Demand Draft (DD) in the name of The Registrar, Kerala State Medical Councils, Red Cross Road, Trivandrum, 693035. The payment will be collected via online mode in future, subject to modifications in the e- payment automation system of Kerala State Medical Councils which will be intimated accordingly. Those registered practitioners who are interested in re - enrollment after the expiry of initial three year period, will be allowed to renew their enrollment for the next three years subject to a consolidated payment of Rs.3000/-. If the registered practitioner still desires to practice in the state of Kerala, after the expiry of enrollment and re \square enrollment periods (Total Tenure – 6 Years), he/she is directed to apply for Permanent Registration with this Council, thus requiring to cancel his/her primary permanent Registration in other State / Union Territory concerned. For enrollment procedure the said applicant must submit their application in Form 5 (Annexure -1) along with necessary attested documents as laid out in sub regulation 2 (i) of regulation 8 of National commission for Homoeopathy regulations, 2022 and on verification of particulars submitted by the applicant, our Council will enroll them in Form – 6 [Adjunct (Enrollment) Register] as prescribed by NCH and after verification by the Council, a certified enrollment letter will be issued to the applicant by the Registrar, Kerala State Medical Councils. Afterwards the scrutinized and condensed set of data will be forwarded to Board of Ethics and Registration for Homoeopathy. Those indigenous registered practitioners & PG students of Kerala state who wish to practice/pursue studies in other States may enroll themselves in respective State Councils as per rules laid out by them.

In these circumstances, the enrollment procedure comes into effect from the date of issue of this order
