കേന്ദ്ര ആയുഷ് മന്ത്രാലയത്തിന്റെയും, NCISMന്റെയും പേരും ലോഗോയും അനധികൃതമായി ഓർഗനൈസേഷൻ, സർട്ടിഫിക്കറ്റ്, ഔഷധങ്ങൾ തുടങ്ങിയവയിൽ സർട്ടിഫിക്കേഷൻ എന്ന രീതിയിൽ ദുരുപയോഗം ചെയ്യുകൊണ്ട് വിവിധ സ്ഥാപനങ്ങൾ വ്യാജവും അസാധുവായതുമായ സർട്ടിഫിക്കേഷനുകൾ ചെയ്യുന്നതായി, ശ്രദ്ധയിൽപ്പെട്ടിട്ടുണ്ട്. നിയമവിരുദ്ധവും തെറ്റിദ്ധരിപ്പിക്കുന്നതുമായ ഇത്തരം സർട്ടിഫിക്കേഷനുകളെ ആശ്രയിക്കുന്ന വ്യക്തികളെ ഇത് കഴപ്പത്തിലാക്കുമെന്ന് കേരള സംസ്ഥാന മെഡിക്കൽ കൗൺസിലിലെ ഭാരതീയ ചികിത്സ സമ്പ്രദായ കൗൺസിൽ യോഗം വിലയിരുത്തുകയും ഇതിനെതിരെ നിയമപരമായ നടപടികൾ സ്വീകരിക്കുന്നതാണെന്നും അറിയിക്കുന്നു. ഈ വിഷയവുമായി ബന്ധപ്പെട്ട് NCISM ന്റെ പബ്ലിക് നോട്ടീസ് കേരളാ സ്റ്റേറ്റ് മെഡിക്കൽ കൗൺസിൽ ഔദ്യോഗിക വെബ്സൈറ്റിൽ പ്രദർശിപ്പിച്ചിട്ടുണ്ട്.

In this regards Commission is issuing Public Notice for practitoners and Public at large. You are requested kindly disseminate the Public Notice among the Practitoners/ Organizations of ISM and sensitize them to refrain from such activities.

PUBLIC NOTICE

Certification Using Ministry of Ayush/NCISM Name with Logo-Regarding

It has come to the notice of Ministry of Ayush and the National Commission for Indian System of Medicine (NCISM) that various councils and organizations are issuing false and invalid certifications under the guise of official endorsements from Ministry of Ayush and the National Commission for Indian System of Medicine. This practice is illegal, misleading and can have severe repercussions for individuals relying on these certifications.

Points for Consideration:

Unauthorized Use of Name and logo:

- ❖ For some conferences / National events Ministry of Ayush/NCISM agrees to become a logo partner for that event only.
- ❖ These logos are for printing only on the participation certificate of the main event.
- ❖ It is observed that, along with the main event, many pre-conference workshops related to specific skills indicating certain level of training are also organized by the organizers and the certificates are given to the participants.
- ❖ The printing of logo on such certificates is not allowed as these workshops are not independently endorsed by the Ministry of Ayush / NCISM.
- ❖ Certain entities are fraudulently using the names & logos of the Ministry of Ayush and NCISM to lend credibility to their certifications. **Hence Only certifications directly issued or officially endorsed by the Ministry of Ayush and NCISM are valid.**
- ❖ Many NGO's institutions, registered or otherwise, conduct some small courses related to Ayush, particularly AYURVEDA & YOGA of their own & issue certificates to anyone who complete the course.
- ❖ To show the authenticity, such organizations use Ministry of Ayush / NCISM logo fraudulently. This fraudulent act is punishable under IPC Act.

Reporting False Certifications:

- ❖ If any person/organization/institutions come across any suspicious or false certifications, report it immediately to the authorities of Ministry of Ayush & National Commission for Indian System of Medicine.

Legal Consequences:

- ❖ Entities found issuing false certifications shall face strict legal action under applicable laws. Beneficiaries of such certifications shall also face legal scrutiny.
- ❖ As per sub-regulation (d) of regulation 27 of National Commission for Indian System of Medicine (Ethics and Registration) regulation 2023, "When a practitioner including a teaching faculty of Indian System of Medicine misrepresents his qualifications or presents false qualifications or degree or produces a fake certificate of registration is convicted; he shall be on first time a warning or temporary suspension of a practitioner whose name is enrolled in the State Register

and the National Register, for a period not exceeding three months or with a penalty not exceeding twenty-five thousand rupees be imposed by the respective State Medical Council or the Board as the case may be or with both; and in the event of a second time, a temporary suspension of a practitioner whose name is enrolled in the State Register and the National Register for a period not less than three months and not more than one year or with a penalty not less than twenty-five thousand rupees and not exceeding fifty thousand rupees or both be imposed by the respective State Medical Council or the Board as the case may be; and in the event of third and subsequent conviction there shall be permanent removal of the name of the practitioner enrolled in the State Register and the National Register”.

Advisory:

- ❖ The NCISM hereby issue a warning regarding use of the logo fraudulently as mentioned above.
- ❖ General Public/Stake holders may Exercise caution and report any suspicious activities related to false certifications.

Stay vigilant and ensure that all certifications and endorsements are obtained through legitimate and recognized channels.
