**Order No. E-9599/2025/Homoeo      Date: 08/10/2025**

A complaint has been received in the Council as per ref read as (1) above, demanding action against Dr. Arif Hussain T.M, a registered practitioner of the Homeopathic System of Medicine, for making false allegations against Homoeopathic System of Medicine on social media and other media platforms.

The Council examined the complaint in detail. It has come to the Council's continuous notice that Dr. Arif Hussain T M has repeatedly engaged in actions contrary to Medical Ethics, despite his registration having been suspended earlier

for a period of 1 year with effect from 28/07/2021 on similar grounds of violating medical ethics and defaming Homoeopathic System of Medicine. As per ref (2) the council of Homoeopathic Medicine decided to issue a show cause notice to the doctor and same was issued as per ref (3) to Dr Arif Hussain T M to submit any explanation / reason for not cancelling his registration. Since no explanation was received from the doctor, the Council of Homoeopathic medicine entrusted members of the Council to submit a report on the aforementioned complaint, and the panel submitted their report before the Council as per reference (4).

The Council have examined the report thoroughly and come to the conclusion that the ongoing denigrating campaigns carried out by Dr. Arif Hussain T.M against the Homeopathic System of Medicine through social media and other media platforms constitute serious violations of Medical Ethics. The Council observes that such conduct by a Registered Medical Practitioner tarnishes the dignity of the Homoeopathic profession and is detrimental to the Public confidence in the system.

In the view of the above circumstances, as per the decision of the Council Homoeopathic Medicine Council referred (5) above the Homoeopathic Registration of Dr. Arif Hussain T.M (Reg No.8862 dated 26/03/2010), is cancelled with effect from 02/09/2025, for gross violation of Medical Ethics, in terms of sections 3,5,13,17,18, National Commission for Homoeopathy (Professional Conduct, Etiquette and Code of Ethics) Regulations, 2022.
